Presentations: Heather Ransons	 The COI Schools and After-school domain and the YMCA Snap Ed contract is interested in identifying best practice nutrition language for early childhood providers on school grounds. Heather reviewed the draft best practice recommendations for preschool to grade 12 and asked for feedback. The workgroup recommended: Changing "do" to "will" throughout the document. Adding language that preschool staff will not offer food to calm children, or to encourage appropriate behavior Including a section about healthy fundraising Adding a resource for farm to preschool curriculum in the Nutrition Education section Changing the frequency for preschool nutrition education to being provided weekly. 4. Research Update- Kathleen Merchant	 Hospital births in San Diego County (excluding the naval hospitals) in 2015 showed Sharp Mary Birch had the most hospital births in San Diego County (26%). Scripps Memorial in Encinitas has the highest percentage of exclusive breastfeeding rates at 90.9%. Sharp Mary Birch achieved the baby friendly status this year, so it's great to see that they have the highest number of births countywide. Naval hospitals are encouraged to become baby friendly, but they do not share their data because of the high rates of mobility of enlisted service members. 5. Small Group Discussion	 Ideas to partner with the library included: Sharing the farm to preschool curriculum. Identifying books for the library to highlight in the 1000 books to kindergarten program and in their classes. Providing parents structured and unstructured physical activity resources. Assessing the books the library currently uses and how they can highlight and incorporate nutrition education in the curriculum. Leading a train the trainer on nutrition education and physical activity. Linking their programs with parks and rec programs. We can structure the discussion with the library on how our ideas relate to their goals then ask which opportunities are of interest to them.
