Childhood Obesity Conference Report Outs- All	 By a show of hands, the majority of COI partners attended the 9th Biennial Childhood Obesity Conference. During the binational border pre-session there was discussion on whether schools in the US can accept student physicals from Mexico. There may be an opportunity to support families and schools through the new relationship the County has formed with Tijuana through <i>Live Well San Diego</i>. 	•	can make a more concerted effort to address in the future. AltaMed, a healthcare company in Los Angeles, had a poster presentation on a resource they created to help districts improve wellness policies by incorporating language deemed strong by the WellSAT, and offering optional language from the CA School Board Association and model school policy. Hollywood High School HEAL Zone has a school-based health center and have developed a prescription pad with the Dairy Council of CA for teens to encourage healthy habits. Students that try the school meals program can enter for a chance to win a Fit Bits. A number of school staff are not aware that kids do not have to take milk for reimbursement, they just need to select three of five items, including at least ½ cup fruit or vegetable. It's important for cafeteria staff to offer items to students and encourage them to take as much as they need, as opposed to telling them they need to take certain items. Recess before lunch is a great strategy to help reduce food waste. In Oceanside, breakfast in the classroom was too much of a challenge at middle school so it will not be offered next year. Based on feedback from the districts, it placed a strain on teachers (who were not supportive because it can create a mess in the classroom) and students want more menu options. Elementary schools start late so they do not participate in breakfast in the classroom. The National Wellness Policy Study at the University of Illinois at Chicago presented on the National School Wellness Policy reports which were emailed out on Monday with the meeting reminder. There was a session on the connection between districts with active wellness councils and implementation. 	 SOCO was released 5/30 during the childhood obesity conference. In September, Dan will present the report to superintendents and highlight some of the recommendations. The report stresses that the schools are only one entity that has opportunities to improve the healthfulness of the environment for children. Deirdre will send the report, the four-page summary, and a sample email message to District Reps in August so they can give a heads up to district wellness leads prior to the presentation to Superintendents. Please keep the report and indicators in mind as we start strategic planning. We will take a break for strategic planning in August and wrap up the process in September. As a result we will have a domain-specific logic model and strategic plan which will then guide our new workplan development. Harder + Co. was hired by the County to complete an evaluation of COI. They are currently conducting a scan and will be conducting data collection, interviews, and possibly focus groups.
