Narrowed it down to the following main areas. <ol style="list-style-type: none"> Continue to support implementation and assessment of progress of school wellness policies. <ul style="list-style-type: none"> Continue focus on strong language and implementation of physical education/physical activity, and limiting access to sugar sweetened beverages (SSBs). Increasing after-school integration with wellness work. Supporting safe routes to school/Vision Zero. Continue providing a forum for partner education and collaboration. <p>Identified ideas that were programmatic in nature, which partners can drive and implement into their organizations. Collective impact activities of the workgroup will focus on those that include policy, systems, and environmental changes (PSEs).</p>
