The idea now is to create one toolkit which will include sections for each domain. • For the Healthcare Domain section, the workgroup brainstormed including resources to support the different ways that healthcare providers can help spread the 5210 messaging. Composed of different videos, printed materials, provide files, etc. Scripps Hospital provides 5210 training resources which could potentially be something to also include in the toolkit. • In the past, Chula Vista has had a 5210 school assembly and fairs. - There have been over 150 referrals received across the three clinics including Rady Children's, Grossmont, and San Ysidro. Among those referrals, there have been eight to complete the program. There have been about 55-60% to complete the first initial call.
- All calls will be ending on June 30 for all clinics. 211 is currently completing an evaluation on those who didn't complete the program. About 25 % of that 156 referrals are still active and taking calls.
- Everything will be finalized within the next few months.

Healthcare Provider Forum

- Health Education and Cultural and Linguistics Workgroup held their meeting last week, and they brought up the ongoing conversation about collaborating with this workgroup on providing a training with the managed care plans in early fall for providers related to childhood obesity. They are open to chair a provider training in Q1 of 2019. They now have to get approval from the Healthy San Diego Quality Improvement Committee.
- Regarding a space to fold the forum, Rady Children's at the EOB can hold 150-180 people and might be a suitable spot. Once a date is established, Mary Beth will reserve the facility if it is available.

Breastfeeding Promotion

- The Breastfeeding Coalition had their July meeting and Kim talked about the Healthcare domain and the workplan efforts. The workgroup might be interested in helping to disseminate the coalition's events and information. This could lead into a great opportunity for the domain to be a part of the breastfeeding roundtable.
- The Lactation Support of Environments has been working on a survey to try and map out the breastfeeding support and research that is going on throughout the county. When all of the survey data is in, UCSD Mother's Milk research team will map the data graphically to show the connections between people, similar to a social network analysis. At the next meeting they will go over the results and decide who else needs to be a part of the conversation.
