1. Announcements/COI Updates	 Dr. Sidelinger announced he would be leaving his position as the Interim Deputy Public Health Officer for San Diego County and was attending his last meeting as the Co-chair for the Healthcare Domain The County has announced their intent to award the contract for the backbone organization of the COI to UCSD. All parties will work together to make this a smooth transition. An application for funding to expand the 2-1-1 for Healthy Kids Project was completed on August 8 Kathleen Merchant has been in touch with Jane Heinig, with UC Davis, who presented at a forum for the Healthcare Domain in March Jane is interested in doing more trainings in the San Diego area There may be an opportunity to incorporate this training into the Rady Children's Hospital Grand Rounds This might also be a good fit for Scripps' Grand Rounds The Health Education and Cultural Linguistics Workgroup (HECLW) will be hosting a Trauma-Informed Care training tentatively set for October 18 – this fulfills a requirement for providers to be trained on screening for trauma 	
2. Provider Advisory Council Update	 The Workgroup has been working to plan a Provider Advisory Council (PAC) gathering to bring together pediatricians, family practitioners, and other relevant providers to address needs around obesity prevention in healthcare settings This meeting was tentatively planned for September, but will be put on hold due to the COI contract transition 	
3. Integration Summit Updates/Discussion	The Integration Summit is a free day-long conference that addresses the overlap between behavioral and physical health – the focus is primarily on adults, but also incorporates information for children	





	 The COI has secured a 1 ½ hour session to look at screen time and its impact on behavioral health (potential speaker – Dr. Twenge) The event is tentatively set for December 4th at the Jacobs Center 	
4. Childhood Obesity Awareness Month	 The COI will be promoting 5-2-1-0 all month in September through activities and social media for Childhood Obesity Awareness Month Planned events include the following: September 9th press conference at the Jackie Robinson YMCA to include the COI Leadership Council and speakers from the YMCA, County HHSA, and the San Diego Hunger Coalition The COI will partner with Red Cross WIC in the afternoon of September 10th for a Live NBC segment – Dr. Sidelinger will speak about childhood obesity and the new WIC EBT card The City of Chula Vista will be officially announcing Childhood Obesity Awareness Month through a Proclamation on the evening of September 10th On September 14th, YMCA branches across the county will hold an Open House with waived member joining fees and a variety of activities to promote 5-2-1-0 and healthy living 	
5. UHC 5-2-1-0 QI Project Updates	 UHC is planning in-service trainings on HEDIS starting with one clinic (e.g., Borrego Health) – to focus on BMI screening and increasing documentation Ideally clinicians will be provided with a link to 5-2-1-0 materials and referral options for nutrition education as part of this process The COI will work to explore available resources and put something together that will be useful for providers. The following existing resources were shared during the meeting. 5-2-1-0 Provider Toolkits Arizona – Clinical Toolbox Includes healthy lifestyle screening tool, effective communication handout, coding info, laboratory assessment of medical risks of childhood obesity, etc. Let's Go Maine (<i>the COI resources were adapted from this</i>) – Healthcare Toolkit Includes a variety of resources to incorporate 5-2-1-0 into practice including information on 	 COI team Modify existing or create new 5-2-1-0 materials to support UHC QI project Share existing toolkits that use 5-2-1-0 or similar messaging Reach out to 2-1-1 to see if they have a database of resources for the Borrego Springs area
