Announcements

Potential collaboration between Health Care and Early Childhood Domain

- CDPH has asked WIC to keep appointments with children
- Head Start has also asked WIC to keep these appointments to allow children to keep their immunizations up to date
- Asking health care providers to put strong regulations in place to keep children and families safe
- Potentially go through AAP or a larger organization to get list of precautions that will be put in place to report back to WIC families to reassure them
- AAP will begin sending members to an advisory board for COI – can ask these members to support with this request

Champion Provider Fellowship

- Through the CalFresh Health Living Program, recruiting health care providers for this fellowship to help address childhood obesity
- 2-year fellowship

Provider Workshop

Need to conduct focus groups for provider workshops to gauge community stakeholders' experiences with seeing health care providers about weight management and food security challenges

Brainstorm for questions to ask at these provider workshops

- Are there any experiences that were impactful to you? What made them impactful?
- What language makes you feel comfortable discussing these topics?
- Ask community members what they're currently doing so that providers can better meet them where they're at, instead of making assumptions about how the parents are feeding/caring for their children
- Ask community members if they've been connected to resources like CalFresh, etc.
- Ask community members if there are resources in their community – do they have a grocery store close to them? Do they live in a neighborhood with built outdoor spaces for activity?
 - Understand the structural vulnerabilities that community members experience
- Ask community members what they need to address this issue
- Share a provider perspective with community members and ask how community members' perspectives compares and contrasts with provider view
- Gauge how community members see accessing benefits and if the public charge rule has/continues to influence this
