USDA Farm to School Grant

Congratulations to San Diego Unified School District Food & Nutrition Services and Leah's Pantry! Leah's Pantry is a recipient of a \$92,500 USDA Farm to School Grant. The Leah's Pantry Barrio Botany project will support San Diego Unified School District's Farm to School Program through on-site production of salad bar ingredients at school gardens in high poverty, low opportunity neighborhoods. Fruits and vegetables grown by students will be harvested and used for school cafeterias, instruction that increases local food consumption among students, and food and agricultural literacy improvement. Advocacy

This past month, the COI signed letters of support for two pieces of legislation in partnership with the California Food Policy Advocates (CFPA) and the San Diego Hunger Coalition (SDHC).

- CFPA requested for the USDA to extend critical child nutrition waivers through this
 upcoming school year to allow schools to continue serving free meals and snacks
 to its students while they are not physically attending school. This nationwide
 request recognizes that grab-and-go meal sites have been and will continue to be
 integral to meeting nutritional needs of students throughout the school year.
- SDHC is endorsing the *Pandemic Child Hunger Prevention Act*. This act would make all children eligible to access breakfast, lunch, and after school snack programs either in school or through "grab and go" and delivery options.

The Foodshed Small Farm Distro is a farmer-owned resource and distribution hub dedicated to growing a resilient, just food system in San Diego. They are now open for new members to join. Options include a no-commitment one week opt-in as well as monthly subscriptions. Weekly purchase availability opens Wednesday through Friday for Saturday and Tuesday pick up or Tuesday home delivery. 
A Virtual Symposium Hosted by the Health and Human Services (HHS) Office of Minority Health: September 17, 2020. 9:00am - 3:00pm PST.
